Roll Call

Ms. Atkins called the roll.

Welcome and Announcements

Mrs. Bulthuis welcomed all in attendance.

Mrs. Bulthuis shared that Governor Cooper announced that the State is now in phase 2.5 and that the Board is allowed to meet in person. Mrs. Bulthuis asked the Board to let her know their preference for meeting in person or holding meetings remotely for the rest of the year.

Mrs. Bulthuis also noted that our meeting is being held as a committee of the whole and that all Trustees are allowed to vote on any action item that comes to the Board. All votes will be taken by roll call and recorded per SB 704.

Carol Holton joined the meeting at 7:02 p.m.

Approval of the Agenda, August 2020 Board Minutes and the August 19, 2020 Called Meeting Minutes - Action

Mr. Knowles made a motion, seconded by Mrs. Capel, to approve the agenda for the September 9, 2020 meeting, the August 2020 board minutes and the August 19, 2020 called meeting minutes. On a roll call vote, the motion passed unanimously.

Board of Ethics

Mrs. Bulthuis read the ethics statement, reminding the Board of Chapter 138A of the State Government Ethics Act and the Montgomery Community College Board Policy 1.4 Conflict of Interest, and asked if there were any potential or actual conflicts of interest.

No conflicts of interest were declared.

STANDING COMMITTEE REPORTS

The committees conducted their business as a committee of the whole.

Budget and Finance Committee

August Financial Reports – Appendix B-1 (Action)

Dr. Bledsoe presented Appendix B-1, the August Financial Reports.

- As of August 31, 2020, County fund expenditures were \$128,300 or, 16% of the budget.
- As of August 31, 2020, there were \$398,794 available for Capital Expenditures.
- As of August 31, 2020, State funds expenditures were \$1,142,933.
- As of August 31, 2020, the Institutional Fund balance was \$765,767.
- As of August 31, 2020, the balance in the STIF account was \$198,663.

Dr. Katie Dunlap joined the meeting at 7:09 p.m.

Mrs. Hensley made a motion, seconded by Mr. Knowles, to approve the August Financial Funds reports. On a roll call vote, the motion passed unanimously.

July Foundation Fund Statement – Appendix B-2

Dr. Bledsoe presented Appendix B-2, the July Foundation Fund Statement. As of July 31, 2020, the balance of Foundation Funds totaled \$4,162,684.47.

The Foundation nonevent raffle will be held virtually this year. Tickets are being sold and the drawing will be held on September 25 at 6:00 p.m. on Facebook.

Building and Grounds Committee

Facilities Report – Appendix C-1

Dr. Bledsoe presented Appendix C-1, the facilities report.

Construction is continuing on the new Counseling Center with sheetrock being finished and new ceilings installed. The area is also receiving new LED lighting. The Blair auditorium has been filled. An existing electrical panel has been relocated with new power and data outlets to be installed in the floor before concrete is poured. Maintenance staff have been busy with various projects and cleaning the campus.

Construction Update – Appendix C-2

Dr. Bledsoe presented Appendix C-2, the Construction Update timeline.

The second phase of building renovations and HVAC upgrades in Blair Hall have mostly been completed. The restrooms are waiting for corrections. The State Construction Office inspection will be conducted to put together a punch list for items needing attention in September.

The second round of renovations in Blair Hall will include a new entryway near the newly constructed Student Services and a new Counseling Center. Also, the auditorium has been filled, an electrical panel relocated, and new power & data outlets installed in the floor before concrete will be poured. The outdoor amphitheater will be reconstructed to include a shelter and dusk to dawn lighting. The new counseling center and a general use conference room have been framed and sheetrock installed. The area is receiving a new ceiling and LED lighting.

Campus Security Report – Appendix C-3 (Action)

Dr. Bledsoe presented Appendix C-3, the Campus Security Report. Dr. Bledsoe reported that there were no offenses to report. He also noted that there will need to be an update made to replace the Crisis Council on the list of resources.

Mr. Knowles made a motion, seconded by Ms. Hensley, to approve the Campus Security Report with changes on the list of resources. On a roll call vote, the motion passed unanimously.

Update on Agricultural Greenhouse Construction – Appendix C-4

Dr. Bledsoe presented Appendix C-4, the update on the Agricultural Greenhouse Construction.

Dr. Bledsoe updated the Board on a location change for the agricultural greenhouse. He noted that one greenhouse and one high tunnel house will be constructed and that the goal is to keep those close to the CTE Center.

He presented three location options and noted that option one would be costly to prepare the site pad for the greenhouse construction. Option two and option 2a is significantly cheaper than option one and would allow for money left over to be put toward repairing the pole shed on campus. Dr. Bledsoe noted that once he receives direct quotes, he will bring this item back to the Board at a later meeting.

Naming of Gunsmithing Room – Appendix C-5 (Action)

Dr. Bledsoe presented Appendix C-5, the naming of the Gunsmithing Room.

Dr. Bledsoe reported that Bear Creek Arsenal approached the college over the summer and met with Mark Dye, Director of Gunsmithing, for a tour of the Gunsmithing Program. Bear Creek Arsenal asked what the specific needs were for the Gunsmithing Program at this time. Mark Dye provided a list, which included several options, they selected the Bluing Room Renovation at \$15,000.

The Bluing Room is being expanded into the old Welding Lab and this room will only be used by the Gunsmithing Department. In comparison to other classrooms it is smaller than most.

Mrs. Capel made a motion, seconded by Mr. Knowles, to approve the name of Bear Creek Arsenal for the Bluing Room in Gunsmithing. On a roll call vote, the motion passed unanimously.

Personnel Committee

Curriculum/Student Services Committee

Update from Vice President of Instruction – Appendix E-1

Dr. Bledsoe presented Appendix E-1, the update on Instructional Activities.

Due to COVID-19, the majority of students are choosing to learn online so far this fall. Faculty continue to meet in class for those who wish to come to class and provide online opportunities for those who want to learn from home. Sam Britt continues to work with faculty to improve the online experience for students. The Career and Technical Faculty have worked hard to integrate their courses on Blackboard and are looking for additional ways to get students involved. The addition of new Go Pro cameras will allow faculty to have “hands free” recording when filming technical projects.

Basic Law Enforcement Training – BLET currently has 16 students enrolled and three to four students that are still working on completing their enrollment paperwork. The class numbers are comparable to last year’s record class and continues to be a testament to the quality of the program and all of Pete Herron’s hard work at recruiting. BLET classes begin September 9.

Taxidermy day and evening classes have seen an influx of new students this semester with 20 students enrolled in the program between curriculum and continuing education. The class this fall includes students from as far as Alaska and five female students. Carolina All Out continues promoting the programs at the College. The filming crew was on campus in early August to film a segment with Len Fagan and the Gunsmithing program for an upcoming episode.

The renovations to the corrections and law enforcement training facilities in Building 500 have begun. The remodeling will allow the College to host two concurrent basic corrections officer training classes, professional development courses for current corrections officers, BLET classes, and ongoing law enforcement officer training for current local law enforcement officers once the renovations are completed.

The Early College started this fall with 68 new freshmen along with 67 sophomores, 58 juniors, 56 seniors, and 14 fifth year seniors. This brings the total this fall to 263 and the largest annual enrollment in the MCEC. The students are working hard to keep connected in these difficult times. The Educational Partnership staff is reaching out to all CCP students to check in with them and to make sure that students have access to the resources they need to be successful.

Update on Continuing Education – Appendix E-2

Dr. Bledsoe gave an update on Continuing Education activities as presented in Appendix E-2.

College and Career Readiness is now offering 100% online high school equivalency class options through the recent purchase of Aztec software. Students still have multiple learning options such as in person instruction, alternative learning packets, and hybrid courses that allow students flexibility to be successful.

Small Business Center completed the LEAD program (Leadership Enhancement and Development) through the Small Business and Technology Development Center. The Small Business Center continues working closely with MCC's Director of Business & Industry Services and Montgomery County Schools to identify businesses that are able to offer free WiFi options to students near their business.

In partnership with the SECU, Continuing Education will be providing four full scholarships to four Wallace and Dunn Heating & Air employees to receive advanced heating and air training.

Continuing Education is collaborating with the Director of Educational Partnerships to deploy a recruitment campaign to enroll high school students into the Youth WIOA program also referred to as the NEXTGen Youth program. NextGen serves youth who require additional assistance to enter or complete an education program or to secure or hold employment. Both in-school youth (ISY) and out-of-school youth (OSY) who have a documented barrier may be eligible to receive services.

Update from Vice President of Student Services – Appendix E-3

Dr. Bledsoe gave an update on Student Services activities as presented in Appendix E-3.

Using Covid-19 relief funds made available from the State of North Carolina, the College has hired a part-time technology tutor to help students learn how to use the educational tools available to them in Blackboard, our online learning management system. The tutor will help any student needing additional help, but a primary focus is on helping students new to online learning. We hope to hire at least one more technology tutor soon.

Legislative/Public Relations Committee

Legislative Updates – Appendix F-1

CC20-055 – Readoption of Temporary Amendments for COVID-19 – Appendix F-1

Dr. Bledsoe presented Appendix F-1, CC20-055 Readoption of Temporary Amendments for COVID-19.

On 19 March 2020, the State Board of Community Colleges adopted four temporary amendments in response to the COVID-19 outbreak. The amendments gave colleges flexibility in responding to budgetary and scheduling impacts associated with the outbreak. They were set to expire on September 15, 2020, but the State Board has readopted the amendments, extending them for another 180 days. Those included in the extension are listed below.

General Provisions - The flexibility colleges currently have to make up instructional time due to adverse weather events is extended to emergency events.

Student Activity Fees - This change allows colleges to use student activity fees to address impacts associated with the COVID-19 outbreak.

Instructional Technology Fees - This change allows colleges to use instructional technology fees to address impacts associated with the COVID-19 outbreak. It also allows colleges to use the fees to purchase computers and other technology for the use of college employees.

Bookstore and Bookstore Commissions - This change allows colleges to use excess bookstore revenues to address impacts associated with the COVID-19 outbreak.

Marketing/Public Relations Update – Appendix F-2

Dr. Bledsoe shared Appendix F-2, the Marketing/Public Relations update. He noted several press release stories that were sent to media outlets as well as those posted on the Colleges social media. He also noted that the college has a new TrailGuide which is replacing YourSpace.

Institutional Status Committee – No Update

Mrs. Bulthuis shared that the Board of Trustee By-Laws are being reviewed by Campbell Shatley for updates and will be presented to the Board at a future meeting.

SGA Report – Appendix G

Ah’Jada Ingram, SGA President, gave an update on SGA activities presented in Appendix G. She reported that SGA Senators approved the addition of two new clubs. The SGA will sponsor Mid-Term Mania on October 16 and SGA Officer elections will be held in late October.

President’s Report – Dr. Chad Bledsoe – Appendix H

Dr. Bledsoe reported on activities since the last meeting and upcoming activities as noted in Appendix H. In addition to his report, he noted the following:

- Dr. Bledsoe shared that he has held several virtual meetings at the State and local level to stay up to date on the COVID-19 pandemic.
- Dr. Bledsoe noted that the Governor's budget recommendation includes funding for Community Colleges.
- Dr. Bledsoe shared a COVID-19 update for the fall semester. There have been a limited number of positive tests with students and employees, but there has been no person to person transmission on campus.
- Dr. Bledsoe noted that he is teaching a class this semester and that the class is going well.

Chairman's Report – Claudia Bulthuis, Chairman – Appendix I

Mrs. Bulthuis presented Appendix I, the calendar of events; she noted that due to the COVID-19 pandemic, upcoming events have been cancelled. In addition to the calendar, she noted the following:

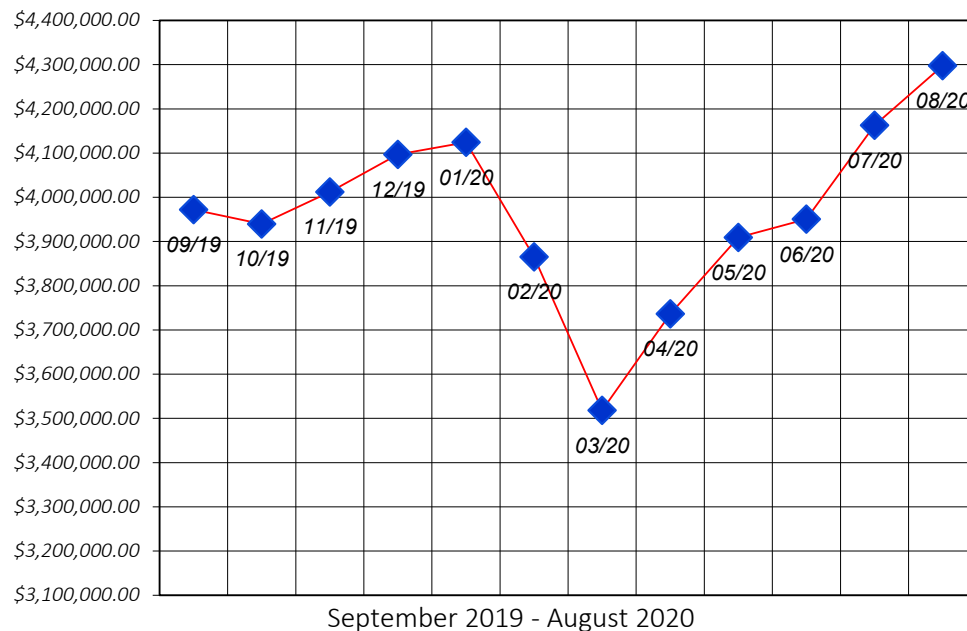

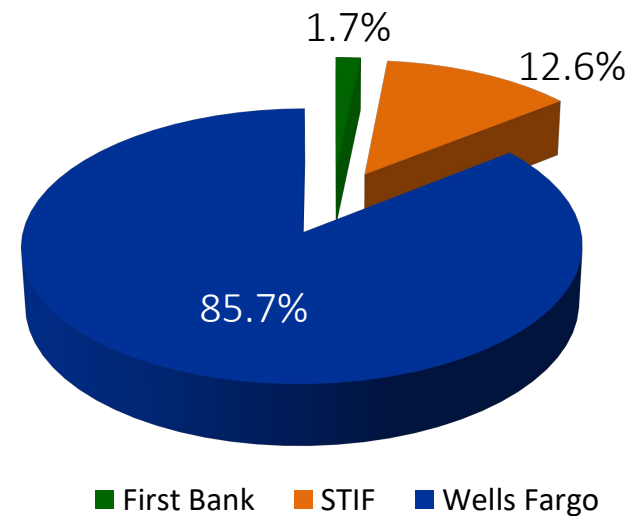

- **Blair Hall (100) Renovation, HVAC and Roof Replacement**

1st phase for roof replacement – The roofing project has been completed.

2nd phase (building renovations and HVAC upgrades) Most of the renovations have been completed. The restrooms are waiting for punch list corrections. The State Construction Office inspection will be conducted to put together a punch list for items needing attention in October.

- **Blair Hall & Outdoor Amphitheatre Renovations**

The 2nd round of renovations will include a new entryway near the newly constructed Student Services and a new Counseling Center. Also, the auditorium has been filled, an electrical panel relocated, and new power & data outlets installed in the floor. The concrete has been poured, ground, and polished. The outdoor amphitheater will be reconstructed to include a shelter and dusk to dawn lighting. The new counseling center and a general use conference room are close to completion.

- Budget: (NC Bond) \$459,286 (Adv Planning Grant) \$20,676
- Disbursed to Date: \$0

- **Building 500 Renovations**

Demolition of the 2 areas, rooms 502 and 512, have been completed. Floors have been polished in room 512. The next step is to have the areas painted and LED lighting installed in room 502.

- **Road Between Blair Hall (100) and Building 500**

Widen the one-way road between Blair Hall and Building 500 to convert to two-way traffic. Demolish building and slab, remove chain link fence, and remove existing speed bumps. Add dirt, grade, seed and straw disturbed area. Provide asphalt patching. Supply and install 4 asphalt speed tables with handicapped walkways across tops. Paint 4" wide striping lines and widen sidewalk at Building 500.

As manufacturers seek to fill 4.6 million high-skill, high-tech and high-paying jobs over the next decade, MFG Day (Friday, October 2nd) empowers manufacturers to come together to address their collective challenges so they can help their communities and future generations thrive. The Class of 2020 LPN students passing rate is 93%. All fifteen students have completed the exam with fourteen passing on the first attempt. Congratulations to all the students who were successful in this trying year.

Mark Nova from Anvil Gunsmithing visited the Gunsmithing classes in September. Mark shared some interesting firearms with the students. Mark is not only an accomplished gunsmith, he is also an avid blogger and shared tips with the faculty on how to reach new markets of students for both curriculum classes and NRA short-courses.

Career and Technical Education programs have begun to do “live projects” including Heating and Air, Masonry, and Automotive. The Forestry students were able to do some controlled burns in the Forestry lab forest this month. Conditions were right for the first time in over a year for the students to be able to participate in this training.

In conjunction with continuing education and curriculum programs, MCC is expanding **evening programs in the CTE Building**. Currently MCC is offering evening programs in Phlebotomy, Welding, Heating and Air, and Nurse Aid. Small Engine Repair, Machining, and Automotive classes are planned for the future. The goal is by spring to have the CTE building busy both days and evenings.

Faculty and Staff continue to work on improving online courses and instruction. A cohort of 10 faculty members are participating in the Association of College and University Educators (ACUE) micro credential in Creating an Inclusive and Supportive Online Learning Environment. The course addresses a wide range of evidence-based teaching practices shown to promote academic and student success. In addition, the College is participating in Quality Matters professional development. QM’s mission is to promote and improve the quality of online education and student learning nationally and internationally. The participation in QM is made possible by the NCCCS use of their Cares Act funding.

Educational Partnership staff, along with Faculty and Student Support staff continue to monitor student participation and success in classes during the pandemic. They continue to reach out to students to see how they are doing and to offer help and resources if they are needed, and to keep MCS counselors updated on CCP and Early College student progress.

Student Success Story: Luke Morton

- Forestry Technology Management student, Luke Morton applied and was approved for the Finish Line Grant to help him overcome unforeseen financial challenges. The challenges nearly forced him not to continue with his plan of study. Luke is now on track to graduate in the Spring of 2021. Beyond financial assistance, Luke has taken advantage of our job search and preparation services to identify employment opportunities in his chosen field of study.

College and Career Readiness

- The College and Career Readiness program is excited to announce our newest team member, Graciela (Gracie) Gonzales. She is our new part-time ESL (English as a Second Language) Navigator. She has been a tremendous asset in developing our ESL community outreach. As a result of her efforts we have enough students to begin an ESL evening class in Biscoe. We are also close to securing enough student interest to offer a day program in Biscoe and an evening program in Candor.

Small Business Center (SBC)

- Launched the inaugural Workforce Development Center (WFDC) Newsletter that briefs internal and external stakeholders/partners on the happenings of the Continuing Education Department. The first issue was wildly successful. We had a 30.8% open rate among the 2,300 subscribers. The average open rate for most organizations is 10%.
- Our social media campaign focused on keeping small business owners motivated and informed launched this month. Below are the details:
 - Campaign - Monday Motivation post of encouragement to entrepreneurs to keep going and to keep being positive during this pandemic.
 - Campaign - Business Tips (Wednesday posting) - promoting various business tips to reach clients/potential clients in a new way.

Business & Industry Services

- In collaboration with all Continuing Education Directors and the Dean we gave a virtual presentation to the Montgomery County Department of Social Services on our programs and services. The goal was to raise awareness and strengthen the referral pipeline.

Workforce Innovation and Opportunity Act (WIOA)

- This semester staff has issued \$2,000 in Finish Line Grant funds. The Finish Line Grant program was created to help community college students 50% complete with their program complete their training when facing unforeseen challenges. Financial emergencies like car repairs, rent, utility bills, childcare expenses, internet bills, and car insurance are some of the expenses we can seek to provide assistance for students.

Update from the Student Services Division

As with most other college-related processes, recruitment activities have taken on a different look because of Covid. The CACRAO (Carolinas Association of College Registrars and Admissions Officers) fall recruiting tour circuit was canceled. 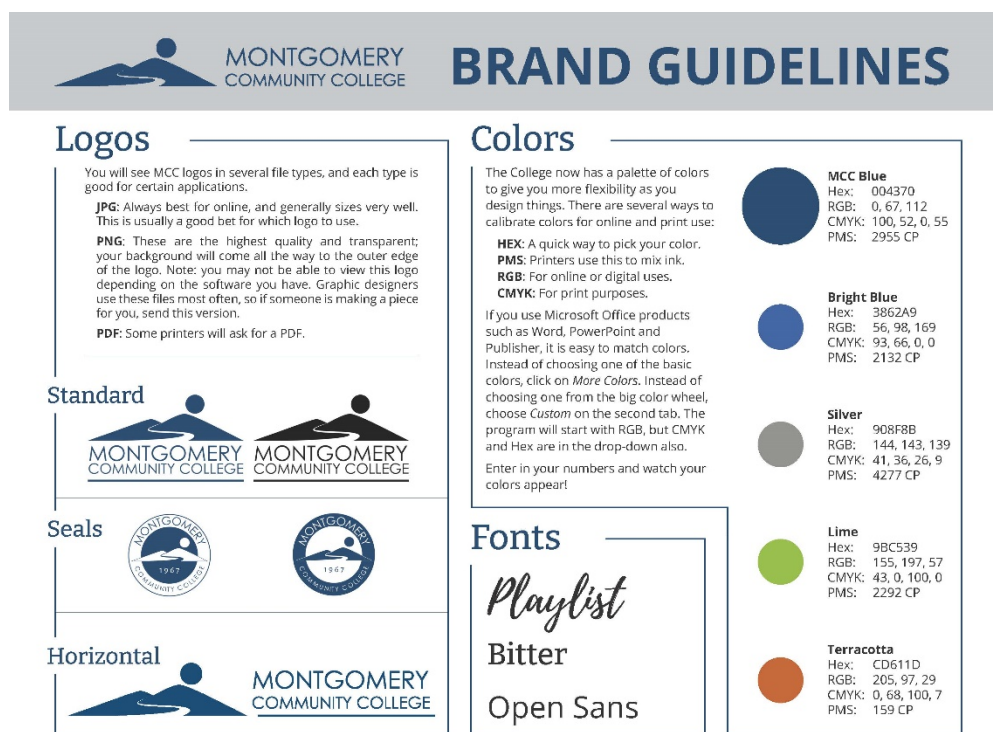

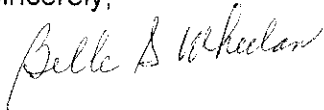
